

REGULARIZATION: QUICKSART

WHO CAN APPLY FOR THE PERMIT?

CASE 1) EMPLOYERS

Italian CITIZENS

European CITIZENS

Third country CITIZENS holding a EC long-term residence permit

HIRING

A FOREIGN WORKER, also irregular, present in Italy by March 8, 2020 and who has not subsequently moved away

- To whom the police took your fingerprints
- or who declared his/her presence at the police station (STAMP on the passport)
- or who holds certificates consisting of documentation dating to a certain period issued by public bodies

CASE 2) FOREIGN WORKER, ALSO IRREGULAR (residence permit EXPIRED ON OCTOBER 31, 2019)

WHO HAS ALREADY WORKED in the following sectors:

- agriculture, livestock and animal husbandry, fishing and aquaculture and related activites
- assistance and personal care
- Houseworks

AND ASKS TO BE HIRED in the abovementioned sectors

HOW TO APPLY CASE 1) – EMPLOYERS

- Sportello Unico Immigrazione Single Immigration Desk (computerised ONLY)
- https://nullaostalavoro.dlci.interno.it/
 - Euro 500.00 for each worker

CASE 2) – FOREIGN WORKER

- Police Office through POST OFFICE "Sportello Amico"
- Euro 130.00+30.00+16.00 revenue stamp
- Identity Card or equivalent document, even expired, at the time of application
- Identity document valid at the time of convocation at the Single Immigration Desk

WHEN TO APPLY FOR IT?

From 7.00 am of June 01, 2020 To 10.00 pm of July 15, 2020

WHICH WORKING SECTORS ARE INCLUDED?

- agriculture, livestock and animal husbandry, fishing and aquaculture and related activites
- assistance and personal care
- Houseworks

WHAT ARE THE REQUIREMENTS?

CASE 1 EMPLOYER

- Minimum taxable income of not less than 30 thousand euros: (in the agriculture, livestock and animal husbandry, fishing and aquaculture and related activities sectors)
- Annual income of not less than € 20,000 / € 27,000 (in the areas of assistance and personal care and housework)
 - No income limit for those with limited self-sufficiency and hiring one person

FOREIGN CITIZEN

- also IRREGULAR
- PRESENT in Italy by March 8, 2020
- AND WHO HAS NOT subsequently moved away (fingerprints/declaration of presence/public documents)

WHO ASKS to be hired/regularised
In the abovementioned sectors:
- THERE IS NO QUOTA -

CASE2 FOREIGN CITIZEN

- holding a residence permit expired by October 31, 2019
 - AND WHO has worked

in the following sectors:

- agriculture, livestock and animal husbandry, fishing and aquaculture and related activites
- assistance and caretakers
- Houseworks

THERE IS NO QUOTA

HOW LONG DOES THE PERMIT LAST? At least 6 months, convertible in work permit for the following sectors:

- agriculture, livestock and animal husbandry, fishing and aquaculture and related activites
- assistance and caretakers
- Houseworks

OBSTACLES?

- Criminal convictions (even not final) for certain crimes
- Expulsions due to dangerousness
- Reported through Schengen system (SIS)
